REGISTRATION GUIDELINES

- Registration begins **May 1**, and extends until camp if full.
- Only current members of Christian Home Education Association of Central Texas (CHEACT) may register. Membership must remain active through the camp dates.
- Extended family members who do not reside with you (grandparents, cousins, uncles & aunts, etc.) or who are not CHEACT members are not allowed to attend camp.
- Children may only attend camp with their own parents or legal guardians. (Children may not accompany other families even with parental permission.) Please have all children age 18 and over that come with you bring signed liability release forms signed by their parents as well. Children 18 or over must have their own CHEACT membership.
- Registration will be done **THROUGH THE MAIL ONLY**. Hand delivered registration packets cannot be accepted.
- Registration packets will be processed on a first come, first to volunteer, space available basis.
- Your registration WILL NOT be processed unless you turn in the completed and signed Registration Form, Liability Release Form (must be signed by both parents and all children 18 and over who are attending), and full payment.
- We assign one family per cabin. However, if you would like to share a cabin with another family, you must send all the required registration materials for **both families in one envelope**.
- You will receive phone/email confirmation of your registration within two (2) weeks of receipt of the completed paperwork and full payment.
- If your family's name is placed on the waiting list, you will receive a phone call/email in order to determine whether you wish to remain on the list or have your money refunded.
- Families, who habitually break the camp and safety rules and/or create problems, will be asked not to attend future camps.
- Please let us know immediately if there are any changes in your situation, especially if you or one of your family members decides not to attend. The availability of even one slot sometimes makes it possible for a family on the waiting list to attend.

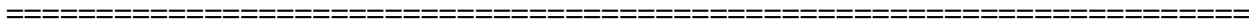
